I understand that the award funds may not be sold, transferred or assigned or converted to cash. I further understand that if I do so enroll, but choose not to continue schooling (at such college or university or another eligible college or university) or choose not to pursue or continue a specialization in fashion design at any point, the award will be rescinded and any award funds already issued for the then-current academic year must be returned to Gucci.
